

**INSTRUCTIONS FOR COMPLETING APPLICATION PAPERS  
FOR  
THE DIRECT DESCENDANTS AND KIN OF DAVID CROCKETT**

1. Direct Descendants must submit a **COMPLETE** application and include documented Proof

Cousins are asked to submit a complete application but are not required to send proof. Proof from cousins is very welcome as it may help others in their research.

2. Proof should be sent for each generation which may be copies of birth, death and marriage certificates, bible records, obituaries, wills, deeds, census records, old letters etc.. Every generation should link with proof to the next.
3. If applicant has been accepted through John or David Crockett in an historical organization that requires documented proof such as DAR, DRT and others, then a copy of their certificate may be used as proof and sent with a **COMPLETED APPLICATION**.
4. If another family member has already been accepted with documented proof and applicant wants to come in on that line, they must send proof up to that link.

**EXAMPLE**

John Doe is a member—son Fred wants to come in, so he must fill out a complete Application and send a copy of his birth certificate linking him with his father. On bottom of application he should include, **Refer to John Doe's applications for proof.**

5. Family tradition is not proof nor are undocumented family sheets done by another family member.

**ONLY COMPLETE APPLICATIONS WILL BE ACCEPTED**

There are times when dates and places are unknown, especially in the earlier generations. Just leave them blank.
